Position: *Elementary Practical Arts Teacher/Artist in Residence for Charter School*

Duties: Seeking an enthusiastic individual to teach Practical Arts in a classroom founded on the core principles of Public Waldorf Education. They will guide and implement curriculum to the needs of the individual child, whilst embracing the unity of the class as a whole. The focus will be on the use of natural materials to include but not limited to: knitting, crocheting, dying with natural dyes, weaving, woodworking, and crafts. A love for working with children, working with colleagues in a collaborative and supportive manner and openness for the unexpected are essential.

Minimum Qualifications:

1. Appropriate experience in Practical Arts and/or a Wisconsin DPI licensure in elementary art
2. Experience/training/certification in Waldorf education desired
3. Must have effective communication skills – oral, written, technological, time management.
4. Maintain organization of the TRCCS practical arts supplies.
5. A love for working with children, working with colleagues in a collaborative and supportive manner and openness for the unexpected
6. Such alternatives to the above that the district may find acceptable

Contract Amount: 15.5 hours a week at \$18.82 or equivalent FTE (salary depending on experience): two 45 minutes periods per week for five different classes grades 1st-6th and 1 hour weekly for the Virtual Charter School, 4.5 hours of prep time, 1.5-hour weekly staff meeting and 1 hour a week for committee work. There is also the potential of recess duties.
